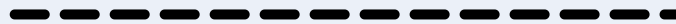

Sponsorship FAQs

Timing

Sponsorship runs from 1 January to 31 December. Prices are excluding VAT. There is no pro rata reduction for companies that decide to sponsor late in the year. Sponsorship is always due for renewal at the end of the calendar year.

Non-sponsors

Service providers who do not wish to donate to the National Pro Bono Centre will be listed in their respective category; alphabetically and by business name alone.

Listing in multiple categories

We recognise that many service providers will be active across more than one category and will wish to be featured as such.

If you wish to sponsor a second category such a listing can be obtained for 50% of the donation amount for that category (providing it is the same donation level as in your first category, or lower, though you are unable to get a discount on a second Diamond donation).

For example:
